My "Mini-festo"

Society has changed rapidly since 1990. But not everyone has felt the benefits in the same way, nor have all of these changes been of help to society, regardless of which political party has been in power. **The aim here is not to take sides with any one political party**, but to set out some standards that ought to apply *regardless* of party, and which people can apply in their lives.

Rather than take a party-political approach, it is sometimes better to consider **what people can do to help themselves**, learning from **Best Practice** in various public and private sectors.

When I did my research for *Integrity* and examined Best Practice, I identified two main management styles: <u>Open</u> and <u>Closed</u>. The Open style is in fashion, but tends to encourage gossip. The Closed Style was mostly abandoned in the 1990s, but has advantages of cohesion and intimacy that work better in some environments.

CAUSES FOR CONCERN:

1) Minimum, legally binding standards in health, environment and social security have not been set. Governments - regardless of political party have few legal obligations to tackle basic issues of air pollution, poverty, ill health and disability. 2a) Governments increasingly rely upon punitive measures for dealing with political protest, and also surveillance of people's web usage, private e-mails and telephone conversations. 2a) There has been a decline in innovation and free speech in the public space; and privacy in the private sphere. This is coupled with a tendency to make personal (often slanderous) attacks on individuals' private lives (particularly sex lives) rather than deal with the important issues. The Internet and tabloid press have both made rumour-mongering into a spectator sport. 3) Simply blaming everything on politicians ignores the damaging effects of poor education and general public ignorance. General public ignorance has meant that it is often the public that calls for less welfare, less compassion towards welfare claimants or genuine refugees and less freedom of expression.

4) The university-educated "experts" often get it wrong. or act to preserve their Special Interests. Their "educated ignorance" needs challenging.

THE SOLUTIONS:

- 1) The general public needs no health or welfare lectures from insensitive "experts" (e.g. feeling bullied into losing weight), because every person is a balance of different needs. When it comes to mental health, what is often most distressing is a lack of individual rights and solutions "imposed" by doctors, counsellors or the general public. We should oppose all forced health interventions wherever possible. They are clearly unethical.
- 2) There is no justification for snooping on the general public. But now that it's law, here are my proposals for how individual can take back control of *some* of their own freedoms.
 - *Think before you send that message.
 Why not encode how you phrase it, or use encryption? The meaning is still the same!
 - *Does it need to go online at all?
 - What about sending it by post, or phoning?
 *If you're upset about someone else's private behaviour, or their relationships, please, have the decency to keep your thoughts offline wherever possible. Don't reveal things that ought to be kept secret, even if you have just "broken up" with someone. Don't reveal e-mails, phone numbers, addresses or places of work if you were asked by someone to keep them private.
 - *Don't try to get people into legal trouble for views <u>you</u> may find offensive or slander them. One day, someone might try to get <u>you</u> into trouble.

3 and 4) Political correctness doesn't reduce ignorance. It just protects Special Interests.

- *It is vital that the arts are at the forefront of resistance. Many people can produce high quality art, music and text on computers. Unfortunately, the tendency is to appeal to the "lowest common denominator". Not everything "popular" is in our best interests.
- *What can we learn from Best Practice?
 Companies use Best Practice to improve.
 We should strive to develop Best Practice
 for everyone, even those not in work, so
 they cope better in challenging situations.
